<b>JUDGES AND JURIES</b>	<p>The number of Juries (judges' panels) may be decided by the Organizing Member Federation depending on the number of participating competitors and judges.</p> <p>All judges must have a current valid FIG brevet.</p> <p>The Juries are set up by a draw and directed by the Technical Delegate from the judges present at the event. Priority will be given to the judges of the highest category. If, on the day of the competition, there are no sufficient numbers of judges in the requested categories, the Technical Delegate may take whatever action needed to secure the running of the event.</p> <p><b>Each participating federation must provide minimum one judge Cat. 1, 2, 3 or 4 with current valid brevet.</b></p> <p>Failure to do so, will result in a <b>fine of 1000 Euro</b> to be paid to the LOC until the Definitive Registration date (<b>10. August 2022</b>).</p>

July 2022</b>. The <b>remaining 50%</b> must be paid by <b>10. August 2022</b>. Since this is an entry fee, it is already due upon registration. All the entry fees are not refundable.</p>
<b>ACCREDITATION</b>	<p>At the accreditation, the heads of the delegation must present the following:</p> <ul style="list-style-type: none"> <li>• Passport of all the members of the delegation</li> </ul> <p>Accurate information about the place of the accreditation will follow.</p>

There will be no qualification if less than 8 athletes/units in categories.</p> <p><u>Finals:</u> Juniors and Seniors: Each final: maximum of ten (10) units: 8 best foreign units (max. 2 per nation) + 2 Austrian units (maximum).</p>

<b>FINAL SCHEDULE</b>	<p>Will be created after the registration deadline.</p>
<b>MEDICAL SERVICES</b>	<p>Official medical person will be provided by the LOC and will stay in the hall every day.</p>

<p><b>COVID 19</b></p>	<p>All participants will take the COVID-19 test upon arrival at the official hotels and must remain in their rooms until the final result.</p> <p>During the entire training and competition period, participants must circulate only in the sport facilities assigned to the event and in the official hotels. In addition to the medical guidelines for the particular event, the FIG requires participants to follow standard precautions.</p> <p>FIG requires all participants, judges and officials to take standard precautionary measures, such as washing their hands and using a mask at all times and, when possible, to keep a physical distance of at least 1.5 meters.</p> <p>The only situation in which it is possible that the safety distance may not be respected is when the coach assists the gymnast during their performances (catching, directing, guarding). This phase should be as short as possible and the person assisting is obliged to use a mask during this time</p> <p>Gymnasts do not need to wear a mask or cover their faces during their performance; in the training area or in the competition area and as far as possible they should maintain a physical distance of at least 1.5 m. physical distance.</p> <p>Additional information will be included in the Work Plan and will be sent to the Federations prior to the event.</p> <p>Please note that the regulations may vary according to the actual COVID-19 situation and may change!</p> <p>Therefore, we ask you to find out about the Covid-19 regulations applicable at the time of your trip on the homepage of the Austrian Ministry.</p> <p><a href="https://www.sozialministerium.at/Informationen-zum-Coronavirus/Coronavirus--Aktuelle-Ma%C3%9Fnahmen.html">https://www.sozialministerium.at/Informationen-zum-Coronavirus/Coronavirus--Aktuelle-Ma%C3%9Fnahmen.html</a></p>
<p><b>VISA</b></p>	<p>Please verify immediately with your travel agent or the Austrian Embassy or Consulate in your country if a visa is required for your travel to Austria. The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before <b>10. August 2022</b> to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
<p><b>INSURANCE</b></p>	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation.</p> <p>Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. Please also refer to <a href="https://www.gymnastics.sport/site/pages/medical-insurance.php">https://www.gymnastics.sport/site/pages/medical-insurance.php</a> for additional information regarding the FIG IMSSA insurance for Athletes and Judges.</p> <p>The LOC will verify the insurance coverage upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). The insurance must be valid at least starting from the arrival day of the delegation and must last for the delegations' entire stay</p>
<p><b>INTERNATIONAL TRANSPORTATION</b></p>	<p>The invited participating federations must pay for the travel costs of their delegation members.</p> <p><b>The LOC strongly recommend that each Federation take a cancellation insurance for their travel.</b></p>
<p><b>LOCAL TRANSPORTATION</b></p>	<p>Delegations can fly to the International airports Innsbruck (AT), Salzburg (AT) or Munich (DE).</p> <p>The LOC can provide an airport transfer or a train station transfer to the hotel and at the time of the stay a local transport from the hotel to the competition hall. However, only the airport transfer or the local transport can be selected.</p> <p>The airport or train station transfer can be used for arrivals on 08. or 09. September 2022 and departures on 11. or 12. September 2022.</p> <p>Please register with the <b>summary form</b>.</p>

<p><b>ACCOMMODATION</b></p>	<p>The summary form must be returned to the LOC by <b>10. August 2022</b>.</p> <p>There are several hotels in different price categories available:</p> <p><b>Category 1:</b> The costs per room/night are as follows:</p> <ul style="list-style-type: none"> <li>• 50 Euro Single Room, including breakfast</li> <li>• 45 Euro (Double room, including breakfast) per person or 90 Euro per Room</li> <li>• 40 Euro (Triple room, including breakfast) per person or 120 Euro per Room</li> </ul> <p><b>Category 2:</b> The costs per room/night are as follows:</p> <ul style="list-style-type: none"> <li>• 70 Euro Single Room, including breakfast</li> <li>• 65 Euro (Double room, including breakfast) per person or 130 Euro per Room</li> <li>• 60 Euro (Triple room, including breakfast) per person or 180 Euro per Room</li> </ul> <p><b>Category 3:</b> The costs per room/night are as follows:</p> <ul style="list-style-type: none"> <li>• 90 Euro Single Room, including breakfast</li> <li>• 85 Euro (Double room, including breakfast) per person or 170 Euro per Room</li> <li>• 80 Euro (Triple room, including breakfast) per person or 240 Euro per Room</li> </ul> <p>The prices for the hotel rooms are normal prices for the region. The Accommodation Form must be returned to the LOC by <b>25. July 2022</b> at the very latest. Since there are only a certain number of rooms per category, the Hotel rooms will be allocated on a “first come, first serve” basis. The delegations must pay for the accommodation expenses of their delegation members. All hotels are located within a maximum radius of 15 km.</p> <p><u>The costs for the accommodations must be paid to the LOC as follows:</u> <b>50 % of the payment – 25. July 2022</b> <b>100 % of the payment – 10. August 2022</b></p> <p><u>Cancellation/Reimbursement Policy:</u> Until 10. August 2022 – 50 % of the payment After 10. August 2022 – no reimbursement of the payment</p>
<p><b>MEALS</b></p>	<p>It is possible to buy a meal in the sports hall. The delegations must pay for the meals expenses of their delegation members. <b>Price per Person per eat: 10,00 Euro</b> Please register with the <b>summary form</b>. The summary form must be returned to the LOC by <b>10. August 2022</b> and the costs for the meals must be paid to the OC by <b>10. August 2022</b>.</p>
