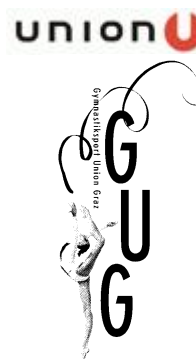

Our **Club GUG-Rhythmic Gymnastics** is organizing the **14th International GUG-CUP**.
It will be a big pleasure for us, if you will accept our invitation, on **Saturday, 7.5.2022**

DELEGATIONS: Each delegation consists of max. 8 persons
(6 gymnasts: **MAX. 2** Gymnasts in the same category, 1 coach, 1 judge).
All Judges are required to be present during the entire competition!

The organising club can enter more participants. Additional exercises of GUG gymnastics will be able to start out of classification.

ENTRY FEE: 35 € per gymnast
Every additional gymnast will start out of competition and will pay 40 Euro
Delegations coming without a judge will be charged a penalty of 50 EUR.


